Where does Micro-Pore Mist go in my client's regimen?

Micro-Pore Mist can be sprayed on after cleansing, morning and night. It should be used before serum and under moisturizer and/or SPF. It can also be used throughout the day or over make-up for a refreshing pick-me-up.

Does this toner contain Salicylic Acid?

No. Micro-Pore Mist does not contain Salicylic Acid. This makes it suitable for clients who use an existing prescription or acne-focused products and don't want to risk sensitization.

Will Micro-Pore Mist replace Breakout Clearing All Over Toner?

Yes, Micro-Pore Mist will replace Breakout Clearing All Over Toner. Micro-Pore Mist is a refreshing pore-tightening and oil-reducing toner whereas Breakout Clearing All Over Toner was more focused on eliminating breakouts.

How soon will my client see results from Micro-Pore Mist?

This formula reduces the appearance of pores after the first application and brightens the appearance of post-breakout marks over time with regular use.

Is the Micro-Pore Mist bottle sustainable?

Yes. To reduce our packaging footprint, Micro-Pore Mist is encased in 50% Post Consumer Resin — a clean, recycled plastic. Over the next year, we will be updating all Clear Start bottles and tubes to use a percentage of recycled plastic.

Why are there some colored specks on the Micro-Pore Mist bottle?

The bottle is made from 50% recycled plastic. Each bottle is one-of-a-kind because it comes from a different source of clean, recycled plastic. Due to its unique material, clients may notice different colored pieces of plastic throughout their products.

Why doesn't Micro-Pore Mist come in a carton like the rest of the Clear Start line?

Micro-Pore Mist is not packaged in a carton in order to reduce our packaging footprint. In the future, Breakout Clearing Foaming Wash will also be sold without a carton. Current products that do come in a carton use FSC (Forest Stewardship Council) Certified paper.

What is the appropriate age range for Clear Start?

Clear Start is ideal for clients in their teens and early 20s.

What is the difference between Clear Start and Active Clearing?

Clear Start is formulated for younger skin, which is more likely to experience rampant breakouts due to excess oil. Active Clearing is formulated for more mature skin, which is likely to experience recurring hormonal breakouts, slower cell turnover, and post-inflammatory hyperpigmentation.

Is Micro-Pore Mist vegan?

Yes, all Clear Start products are vegan, gluten-free and cruelty-free. They are also formulated without artificial fragrances and colors.
